**Crime Update: Counterfeit Check Suspect from
Walmart Oakland Market Arrested**

Gregory Victor Harrington (B/M DOB 09/19/1972 of 1536 Boston Grill Road, Mount Pleasant, SC) was served a warrant for Forgery < \$1000 for counterfeit check case that occurred at Walmart Oakland Market on September 20th, 2009. **(OCA # 2009-P-14490)**

Suspicious Activity was reported at 1150 Plantation Lane in Snee Farm. The female victim said she was walking her dog on the golf course at approximately 0500 hours on February 9th approximately 2 houses down from her residence (possibly 1142 Plantation Lane) when her dog alerted her to a subject walking up behind them. When the victim turned around, she saw a B/M wearing black baggy pants and a black in color sweater approximately 20 feet behind them. The victim's dog lurched for the subject and the subject fled in the same direction that he came. The victim said the subject never said anything to her. The victim described the subject as between 20 to 30 years of age approximately 6'01 140 pounds with black hair. Officers patrolled the area with negative contact. **(OCA # 2010-P-01579)**

A **theft of golf equipment** was reported at 1152 Black Rush Circle in Dunes West. An unknown subject stole a Ping Cobra F driver, blue Ping golf bag, and a set of Ping irons that were packaged to be shipped to Texas and left at the victim's mailbox for pick up by the U.S. Postal Service. The incident occurred between January 14th, 2009 and February 5th, 2010 at 1500 hours. **(OCA # 2010-P-01556)**

A **theft of a camera** was reported at 1701 Beaucastel Road Suite A at Charleston Pediatric Dentistry. An unknown subject stole a black Nikon D-60 digital camera from a countertop in the treatment bay area. Coverall Cleaning Concepts cleans the business after hours and has the alarm code to the business. The incident occurred between February 4th at 1500 hours and February 8th at 0930 hours. **(OCA # 2010-P-01553)**

Mailbox Vandalism was reported at 3218 Morningdale Drive in Ivy Hall. An unknown subject using an unknown object, possibly a bat, struck the victim's mailbox knocking it into the roadway.
