- We have seen yard signs in yards, and again they are not allowed per our covenants and our restrictions committee is handling those. Our graduation banner is an attempt to acknowledge all our graduates.
- Moving forward the HOA took over responsibility for the July 4th parade with a fire truck, parade and popsicles. I will be out of town so I will be looking for volunteers to help.

TREASURER: Mario Rasgo

- On track for our budget for our finances. We have about \$300,000 in our operating fund and \$575,000 in our reserve fund.
- We have two investments in our reserve fund, one is a money market and the other is a
 certificate of deposit. Right now for this year, our money market accrued interest of about
 \$5,800. We expect it to be over \$10,000 this year. Our CD we have only had for three
 months, and right now we have about \$3,000 we have accrued in interest. We are able
 to use some of our reserve funds to get additional income into our accounts.
- If anyone had looked at the financials, there is a bit of an anomaly in there. It says that landscaping is \$118,000 of cost for the month of May, that's pretty high and it looks like a couple invoices that were put in there. It should be around \$59,000 for all the mulch we do throughout the neighborhood.
- Lakes: This time of year we have our lake management guy keeping as pristine as possible but with the warmer weather we have had, it's hard to control. Looking pretty good but still some duck weed that we are continuing to address.
